### **Garry Harris Selected for Georgia Oglethorpe Award by** State Board of Examiners



NTA Past President Garry A. Harris was recently selected by the State Board of Examiners for Georgia's highest level of recognition for organizational performance excellence, the Oglethorpe Award. The Oglethorpe Award, based on the prestigious US Department of Commerce Malcolm Baldridge Award, uses the exact same criteria for evaluating optimum organizational performance. Examiners are trained and certified to determine "Best in Class" performance for organizations ranging from business, industry, government, education, healthcare and nonprofits.

The award criterion provides a framework for executive leadership to use in managing and improving the interdependence between an organization's key business drivers and core processes. Abstracts must have a **title** (15 words or less) and be of **150 to 300 words** in length, and must be accompanied by **full contact information** (not just e-mail address) for the author(s). Submit to **each** of the two editors below (**Electronic Submission Preferred**) no later than **May 31, 2004.**

All presentations should be prepared as PC-compatible **MS Word or PowerPoint files** and provided, at the Conference, on floppy disk, compact disk (CD), or 100-MB Zip disk (as appropriate). The media to be used should be indicated at the time of abstract submission. Presentation time allowed is **15 minutes**.

#### Scope:

The Joint Educational Facilities (JEF) International Student Symposium (ISS) was designed to support the introduction of high school and undergraduate students, who know the excitement of research and discovery, to participation in conferences at this level.

This symposium at SCI 2004 is intended to provide a forum for researchers and practitioners, at the undergraduate and high school level, to present their contributions as technical papers in the following subject areas: computer science, computational science, computer experiments in mathematics, information technology and computer applications in the social sciences and humanities. Artificial Life, i.e, Automata, Genetic Algorithms, Evolutionary Computing;

Open Systems Technologies, i.e., Linux, Star Office; Cluster technology;

Database technology; and Information Assurance/ Security.

### International Conference on Appropriate Technology

Bulawayo, Zimbabwe July 15-17, 2004

#### Theme:

A Knowledge Management Approach to the Development of Appropriate Technology, with a focus on sustainable land-based projects.

The theme of this conference is designed to (1) facilitate research on the management, archiving, and tracking of appropriate technology concepts and projects, through the use of state-of-the-art knowledge management theories and practices; and (2) to focus on projects related to increasing the productivity of land-based projects in a sustainable fashion, while being inclusive of all areas related to appropriate technology.

#### Background:

Underdeveloped countries throughout the world have a majority of their population involved in land-based economy, primarily farming, but also ranching and mining. Despite this economic emphasis, most of these countries are importers of agricultural products, due to low productivity. This, in turn, is due to insufficient or inadequate technology. Therefore, there is a need for more effective technology, which must also be sustainable, and culturally and environmentally sensitive.

#### **Paper Submissions:**

All papers should be submitted electronically in Microsoft Word or .PDF format, single-spaced 12-point font, Times Roman format, **8 page limit.** 

At least one author must register for the Conference in advance of the deadline for paper submissions, for the paper to be included in the Proceedings. Each

The National Technical Association's Board of Directors met January 31, 2004 in Atlanta, GA. NTA past president Garry Harris hosted the meeting, and also represented the newly reinstated Atlanta chapter of the NTA.

Topics included reports by the members of the Executive Board (President, President-Elect [and Conference Chair], Secretary, Treasurer, and Regional Directors), and National Committee Chairs (Policy and Planning, Membership, Operations, Awards, Publications, Finance, and Conference Planning).
